Dear Sir/Madam,

This is to bring to your kind attention that the process for Election to **Goa University Students Council for 2018-19**, has been put into motion, with Notification of the Electoral Schedule on the Website of the Goa University. The Notification, together with the governing Statute (SSA-7), and one set of Forms, has been dispatched, to your respective Institution, via Speed Post, so as to reach you, shortly.

In the meantime, kindly find the same set of documents, sent across to you, vide attachments to this email, for you to immediately display them, on your Notice Board(s), towards giving wider publicity, by disseminating the message, across your Institution.

Also, Principals and Returning Officers, at the Colleges, may kindly note the following guidelines, pertaining to the Election.

(1) **UCRs would be elected at the Level of 'Class' and not 'Divisions'**.

This means that, should a particular discipline have multiple divisions 'A', 'B', 'C', etc., they would elect a single UCR, and not UCRs, for each division.

(2) **'BBA' Course**, whether Gen or Specialized (Shipping & Logistics, etc), shall come under the ambit of Commerce Faculty, and hence, shall be clubbed, with B.Com, for the purposes of electing UFRs.

(3) Similarly, **'BCA' Course**, shall universally, come under the ambit of Science faculty, thereby, being clubbed, with B.Sc, for the purposes of electing UFRs.

(4) **'MBA' Course**, comes within the purview of the Commerce & Management faculty, hence, should be clubbed with Commerce, for the purposes of electing UFRs, though UCRs, shall be separate.
