

Memorandum of Understanding
between
Sangath, Goa
and
Dhempe College of Arts & Science, Goa.

This MEMORANDUM OF UNDERSTANDING is made and entered into on this 31st day of August, 2017 between Sangath, Goa, on the ONE PART and the Dempo Charities Trust's Dhempe College of Arts and Science [hereinafter DCAS], Miramar, Panaji, Goa on the OTHER PART (who for the purpose of this MoU are hereinafter individually referred to as 'PARTY' and collectively referred to as the 'PARTIES').

AND WHEREAS SANGATH is a non-governmental, not-for-profit organisation committed to improving health across the life span by empowering existing community resources to provide appropriate physical, psychological and social therapies.

AND WHEREAS DCAS is involved in education, research and training in sciences and arts.

Now, therefore, in consideration of the premises and mutual covenants hereinafter contained, the parties hereto agree as follows:

Article 1. Objectives

To collaborate in conducting outreach programmes in the community to build awareness about mental health.

Article 2. Implementation

2.1 The Parties agree to constitute an Implementation Committee comprising the following participants:



Article 3. General Provisions

- 3.1 Based on the requirements the implementation committee shall, in consultation with the faculty and professionals, decide on the content and implementation of the program during the tenure of this collaboration.
- 3.2 DCAS shall have the nodal responsibility for mobilizing resources and the conduct of such works.
- 3.3 DCAS shall bear the costs of carrying out the obligations under this agreement. Neither party shall make a claim against the other party for any expenditure unless such expenditure has been agreed upon in writing between the parties.
- 3.4 Any dispute or difference arising between the Parties shall be settled by mutual agreement. The disagreements at the operating level shall be forwarded to the respective higher officials for appropriate resolution.
- 3.5 Nothing in this understanding is intended to affect other cooperation or collaboration between the parties.

Article 4. Tenure and Termination

- 4.1 This MoU shall come into force in September, 2017 upon signatures by the authorized signatories of the parties and shall be valid for five years. It may be amended by mutual written agreement and may be terminated at any time by either party upon one month's written notice to the other party.
- 4.2 All joint activities not completed at the expiration or termination of this understanding may be continued until their completion under the terms of this understanding.

Article 5. Amendments

- 5.1 This MoU represents the entire understanding between the parties and supersedes any and all understandings either oral or written hitherto with respect to the subject matter of this understanding.

5.2 No amendment or modification of the MoU shall be valid unless the same is made in writing by both the parties and specifically stating the same to be an amendment of the MoU. The modifications/changes shall become part of the MoU and shall be effective from the date on which they are executed, unless otherwise agreed to.

Article 6. Assignment

6.1 This MoU is based on the professional competence and expertise of each party and hence neither party shall transfer or assign this agreement, or rights or obligations arising hereunder, either wholly or in part, to any third party.

Article 7. Conflict of interest

7.1 Both Parties warrant that this MoU is not likely to have any conflict of interest with any of their organizational, financial, contractual or other interests relating to the activities under this MoU.

Article 8. Liability

8.1 Both DCAS and Sangath shall be solely responsible for any and all claims and/or damages in connection with the exercise of its objectives hereunder.

8.2 Both parties further agree that no employment relationship or partnership, express or implied, is created between them

Article 9. Activities

9.1 DCAS and Sangath will collaboratively conduct mental health awareness activities in Penha de Franca and surrounding villages.


9.2 Up to 12 such awareness meetings will be conducted in the course of the academic year 2017-18.

9.3 Sangath will provide the training in community networking and delivery of the Prakashdoot module.

9.4 DCAS will provide the students who will act as facilitators of the awareness program and any logistical support required for the program such as overhead projector and screen.
