Memorandum of Understanding (MOU)

This agreement is made on "05/12/2022"

BETWEEN

(1) DCT's Dhempe College of Arts & Science, Panaji, Goa, India

And

(2) Cyber Wellness Centre, St. Inez - Goa, India

Both hereafter referred to as the "Parties" collectively or "Party" individually.

1. Introduction

The purpose of this MoU is to foster collaboration between DCT's Dhempe College of Arts & Science, Panaji, Goa, India and Cyber Wellness Centre, St. Inez - Goa, India for mutual benefit and to facilitate internship.

- 2. The parties agree to collaborate in conducting the Internship Program as under:
 - i. Induction program for students of TYBA psychology about Cyber Wellness Centre.
- ii. The Duration of the Internship program will be for 50 hours spread over 2-3 months for a batch of 20 students.
- iii. Details of students assigned for a batch will be informed to Cyber Wellness Centre at the start of the Internship.
- iv. Students to conduct community surveys and give hand outs to public to raise awareness about cyber safety. Each candidate may take a task to sensitize 100 people about Cyber safety.
- v. Students to prepare the forms for data collection to conduct the survey.
- vi. Students to submit the compiled report of the survey indicating the demographic details of the participants.
- vii. Trainers/mentors from cyber wellness centre to evaluate and monitor the work conducted by each student.
- viii. Seminars and workshops to be conducted jointly by both the parties.
 - ix. Community activity in the form of street plays to be conducted by the students.
 - x. Certificates will be awarded by Cyber wellness Centre upon completion of the Internship program.

3. Faculty from department of Psychology, Dhempe College of Arts & Science, Panaji, Goa, and Cyber Wellness Centre will communicate and meet regularly to promote the collaboration

4. Use of Names, logos, Marketing and Publicity

Neither party shall use the name or logo, or any variation thereof, of other without first obtaining written consent form the other party

5. Review

This agreement will be reviewed annually but may only be varied in writing, signed by the parties (or their authorised representatives).

6. Validity and Termination

This agreement shall remain valid for 3 years unless terminated by:

- a. Mutual agreement between the two parties, or
- b. Either party by 6 months written notice.
